SHINHAN SECURITIES TO LAUNCHES SECURITIES FUNCTION ON SHINHAN SOL VIETNAM MOBILE BANKING

Ho Chi Minh City, 07th of July 2023 – Shinhan Bank Vietnam ("Shinhan Bank") collaborates with Shinhan Securities Vietnam ("SSV") to implement the "Securities" function on Shinhan SOL Vietnam Mobile Banking ("SOL App"). This service includes the function of opening Shinhan securities accounts, depositing money, trading stocks, in order to bring customers with convenient, useful and effective experiences for their investment activities.

Customers, please upgrade the SOL Application to the latest version, log in to your account, select "Securities," and select your preferred service:

With the securities account opening service: This service is available to Vietnamese individuals who open an account through the eKYC process.

With deposit to securities account: Allowing customers to transfer money for free from a legitimate account to a securities account opened at a securities company (a Shinhan Bank partner) using SOL App.

With securities trading service: This function will be sent to the SSV's website to make transactions.

SSV is providing free trading for six months from the date of opening a securities account, as well as a preferential interest rate of only 8.8% and a loan limit of up to VND 5 billion to customers who open an account through the SOL App. Customers who continue to sign in to the "San Xin Ha application" with registered SOL App will additionally receive 100,000 "Xu Xin" bonus points worth VND100,000 VND, which can be used to trade stocks as usual.

The SOL application was updated to the newest version in December 2022, with a user-friendly UI, greater security, and numerous of useful functions. In this latest version upgrade, the SOL App also includes the feature "Apply for online banking with ATM or debit card," allowing customers to register for the service from any location without having to visit a branch or transaction office.

In addition to promoting digital transformation and improving customer experience, the collaboration between Shinhan Bank and Shinhan Securities Company exemplifies the One Shinhan spirit that Shinhan Financial Group in Vietnam is promoting strongly in this market, with the goal of becoming a leading financial group on a global scale.
