- Step 4: Select the exact transaction to convert
- **Step 5:** Select installment conversion tenor and installment interest rate:

Tenor	Interest rate
6 months	21,5%pa
12 months	21%pa
18 months	20,5%pa

- **Step 6:** Confirm installment conversion to complete.

#### Notes:

 Mimimum transaction amount for installment conversion with preferential interest rate is VND 2,000,000.



- Transactions which are cash withdrawal, Flexi-cash, transactions which are due for payment and any other fees however called, including but not limited to, the transaction processing fee, annual fee, cash advance fee, interest, credit card payment, debit adjustment, late fees or any foreign exchange trading are not eligible to convert installment.
